

**JAMES ISLAND PUBLIC SERVICE DISTRICT  
ORDINANCE NO. 2021-04**

**AN ORDINANCE TO AMEND THE FISCAL YEAR JULY 1, 2020, THROUGH JUNE 30, 2021 BUDGET OF THE JAMES ISLAND PUBLIC SERVICE DISTRICT, SOUTH CAROLINA, AS PREVIOUSLY ADOPTED PURSUANT TO ORDINANCE NO. 2020-1; AND OTHER MATTERS RELATED THERETO**

**Whereas**, the James Island Public Service District Commission (the "Commission"), as the governing body of the James Island Public Service District, South Carolina (the "District") previously adopted Ordinance No. 2020-01 dated June 22, 2020 ("Ordinance 2020-01"), the provisions of which authorized and implemented the District's budget for the fiscal year beginning on July 1, 2020 and ending on June 30, 2021 ("Fiscal Year 2021"); and

**Whereas**, under Ordinance 2020-01, the Commission approved the following appropriations for the Fiscal Year 2021 budget:

**Whereas**, during Fiscal Year 2021, the District experienced (a) the unexpected purchase of additional Solid Waste Department vehicles associated with the General Fund due to casualty loss, and (b); unexpected cost increases in the Proprietary Fund due to increased wastewater treatment costs; and

**Whereas**, the Commission wishes to amend the Fiscal Year 2020-01 budget to increase appropriations in response to the above-mentioned circumstances.

NOW, THEREFORE, be ordained by the Commission, in meeting duly assembled, as follows:

SECTION 1: There is hereby appropriated from the General Fund and Proprietary Funds, as referred to in the findings above, certain further appropriations for Fiscal Year 2021; such appropriations shall be made from FY2021 Revenues and Other Inflows in the respective funds, as follows:

SECTION 2: Prior to the date of enactment of this Ordinance and pursuant to the requirements of S.C. Code Section 6-1-80, the Commission did hold public hearing on June 28, 2021 (the "Public Hearing"). The notice of Public Hearing, in the form and format required by Section 6-1-80, was published in *The Post & Courier*, which is a newspaper of general circulation in the District. Publication of such notice did occur not less than fifteen (15) days prior to the date of the Public Hearing and all interested parties were given an opportunity to speak in favor of or against this Ordinance. All actions of District staff as necessary to properly notice the Public Hearing are ratified, confirmed, and approved.

SECTION 3: The Commission ratifies and approves the findings of fact recited above. Further, all actions of the General Manager and other District staff regarding the Public Hearing and drafting, execution and delivery of the notice of the Public Hearing are ratified, approved, and confirmed. Further, the General Manager and other District staff shall be authorized to do all things necessary to implement the provisions of the Budget Amendment.

SECTION 4. All other terms of Ordinance 2020-01 shall remain in full force and effect. If any section, subsection, sentence, clause, or phrase of this Ordinance is, for any reason, held or determined to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5: This Ordinance shall become effective immediately upon approval of the Commission following second reading.
