



MATERIALS THAT CAN'T BE COLLECTED BY JIPSD:

- **Automobile Parts** (motors, tires, rims, doors, fenders, car seats and batteries, etc.)
- **Boats & Boat Motors**
- **Bricks, Rocks or Concrete/Asphalt**
- **Contractor Generated Material** (including construction, floor coverings and yard debris, etc.)
- **Dirt**
- **Hazardous Materials** (solvents, paints, pesticides, herbicides, drain cleaners, petroleum products, gasoline, lead-acid automobile batteries, asbestos, flares etc.)
- **Paint Cans** (unless paint is completely dry in the can with lid off)
- **Roofing Materials**
- **Electronics**

Please do not put any liquid or dry chemicals, ammunition, or any other hazardous waste material for solid waste collections.

Please do not dump these items illegally.

Hazardous Waste can be disposed of by calling Berkeley County Landfill (843) 572-4400 or Waste Management - Oakridge Landfill (843) 563-2607. For procedures on disposal of hazardous waste, visit the Environmental Management Department at www.charlestoncounty.org.

Homeowners can recycle used motor oil and antifreeze at the Recycling Drop Off Center located at a Charleston County Drop Off site. These sites are solely for the collection of recyclables; no trash will be accepted. Check out Charleston County's website for recycling drop off locations and hours of operations.

EASY TO MANUEVER ROLLING CARTS

Each home will be provided with one durable, weatherproof 96-gallon cart that rolls easily to the curb for collection. (Smaller sizes are available upon request.) Customers must utilize JIPSD's standard rolling carts, which remain property of JIPSD. Customers must use the standard rolling carts issued by JIPSD. **Non-District issued garbage receptacles will not be serviced.** At the home owner's request, they can be hauled away for proper disposal.

Additional rolling carts can be purchased by calling our Solid Waste Department at (843) 762-5260. The cost for an additional rolling cart will be the current JIPSD's purchase price. **There is a maximum of three rolling carts per residential household and commercial property. A third cart can be purchased for a \$165 annual fee.** Purchased rolling carts are the property of the purchaser.

For aesthetic reasons, all rolling carts are uniform in appearance. **Rolling carts should not be defaced with paintings or decals.** Garbage should be placed in plastic bags for cleanliness and to assist in the prevention of litter on the streets. **Garbage left outside of the rolling cart will not be collected;** if you have extra garbage, please hold it until the next collection day. Do not over-fill the rolling cart so that the lid will not close. **The rolling cart must be placed curbside by 6 a.m. on collection days.**

If your rolling cart is damaged or stolen, contact the Solid Waste Department at (843) 762-5260 and we will look for the missing rolling cart. Damaged JIPSD owned rolling carts may be repaired or replaced by JIPSD. Rolling carts that are lost or damaged through misuse/neglect will be replaced by the property owner/tenant at JIPSD's purchase price.

JIPSD owned rolling carts damaged through normal wear and tear or rolling carts damaged by a JIPSD Solid Waste vehicle (including a purchased rolling cart) will be repaired if necessary by JIPSD at no charge.

CONVENIENT COLLECTION

Garbage, bulky items and yard debris will be picked up on the same day but with different trucks. Thus, it must be separated for collection. Please note: this **does not include contractor or landscaper generated debris**, as they must haul their own materials and debris away. Property owners are responsible for tenant move outs and evictions.

On collection days, varying vehicles equipped with lifting mechanisms will stop in front of your property to collect allowed amounts of bagged garbage, yard debris, and man-made materials. After collection, you should return roll carts to their storage location the same day and ensure the right-of-way is clear of any loose or stray debris.

BULKY ITEMS

There is a limit of 2 bulk items, or 1 claw scoop of home owner generated materials per week (equivalent to about the size of a standard 96-gallon roll cart).

JIPSD will pick up the following household garbage and bulky items:

- Furniture
 - Mattresses
 - Appliances
 - Building materials related to homeowner repair, such as plumbing; doors; carpets and padding; lumber/boards (less than six feet with nails bent down); windows/ mirrors (with glass taped in an "X" to prevent shattering)
- Remember:*
- Stack debris in the same direction
 - Loose/small debris such as tile, sheet rock, etc. must be broken up and placed in heavy-duty bags
 - Glass items should be placed separately from other debris
 - Bulk cardboard will not be collected. Recycling is managed by Charleston County, and they offer multiple drop-off locations and the option to obtain additional blue roll carts if needed. Call (843)720-7111 for more information.



YARD DEBRIS

Yard debris is collected on the same day as your roll out garbage. To ensure collection, please prepare it in the following manner:

Small trimmings from shrubs or grass clippings, pine cones, and pine straw MUST be placed in recyclable **paper** bags. (Bags suitable for use can be purchased at local retailers.) Loose leaves and grass placed at the curb in piles will not be collected.



Major limbs should be cut less than four feet in length.

Contact our Director of Solid Waste Services at (843)762-5260 before removing trees or placing large stumps curbside for pickup.

Yard debris must be separated from all other trash, construction debris, furniture, or white goods (stoves, refrigerators, freezers, etc.).

Please do not place yard debris to be collected under low hanging power lines or limbs, near parked cars, on top of water/gas meters, adjacent to fire hydrants, on top of sprinkler heads or material that may be damaged by mechanical loading devices. **JIPSD is not responsible for damage caused by the collection of debris placed inappropriately.**

Piles no larger than 5 cubic yards, equivalent to two-claw scoops (or up to 25 bags of yard debris) should be neatly placed parallel with the road.

Leaves, grass, tree limbs and shrub trimmings are recycled by Charleston County into useful mulch and compost that is sold back to the public. To avoid contamination, **do not place animal waste in debris bags or piles.** For more information, please contact Charleston County Recycling at (843)720-7111.

PLEASE REMEMBER:

Recycle used motor oil & filters, batteries, textiles, computers, electronics, left-over paint, and corrugated cardboard at the Charleston County Convenience Center on Signal Point Road.
